

Gift Aid declaration form

I want to Gift Aid my current and any donations I may make in the future or have made in the past four years to Dorothy House Hospice Care. I am a UK tax payer and understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all my donations in that tax year it is my responsibility to pay any difference.

Dorothy House Hospice Care will receive 25p for each £1.00 donated under Gift Aid. This means for instance that every £10.00 raised becomes £12.50 – at no extra cost to you! Just think what a difference that can make.

Please notify Dorothy House Hospice Care immediately if you no longer pay sufficient tax on your income and/or capital gains or you change your name or home address.

By completing this form you are confirming that:

- You wish Dorothy House Trading Ltd. to act as your agent in selling the goods you have brought into the shop. Dorothy House Trading Ltd will deduct a 1% commission + VAT from the gross proceeds for providing this service.
- You are not acting as a business in bringing goods in for sale to any shops belonging to Dorothy House Hospice Care.
- The goods you donated belong to you and not to any other person.

Any goods which cannot be sold will be recycled and cannot be returned to the donor. We reserve the right to terminate this agreement at any time.

Before Dorothy House Hospice Care make any Gift Aid claim we will write to you to inform you of the money raised from the sale of your donations once sufficient items have been sold. You can then choose to retain or donate these proceeds to Dorothy House Hospice Care.
